Notes from the Executive Committee Meeting

The Executive Committee (EC) met on Monday, February 18, 2019, and discussed the following items:

- SHNA treasurer, Joanna Wiorkiewicz-Kuczera, reported that the Association has a balance of \$659.85, and 124 members.
- Our Lawrence Association of Neighborhoods (LAN) representative, Gary Webber, reported that at the August, September, and October LAN meetings the following items of interest to SHNA were discussed:
 - Schwegler is concerned that neighbors were notified of short term rental (STR) but not the neighborhood association.
 - Seven neighborhood representatives met with a representative of the firm facilitating the hire of a new city manager. The representative met with Social Services, Developers, Business, Neighborhoods, and Education. They expect the process to take 5 months.
 - Henderson provided updated information on Kten Crossing regarding the governor's (Colyer) support of the project and KDOT's work with the city to design an acceptable access.
 - Follow these links for the <u>December, 2018</u>, and <u>January 2019</u> LAN meeting minutes.

- Centennial Park Sign maintenance: Webber will contact LPRD to discuss maintenance of the sign at Rockledge and Ninth.
- Non-owner occupied STR at 921 Holiday Dr: Discussion of new city policies regarding notification of neighbors, posting, restrictions, etc. 921 Holiday Dr. is the first known STR of this kind in SH neighborhood.
- 9th and Iowa Quik-Trip development (Webber): Quik Trip is buying the Zarco station(s) at 9th and Iowa and the plans include eliminating 9th St. Terrace, which connects Iowa and 9th southeast of the intersection (see article below).

STR Permit Denied in Sunset Hill

In January, SHNA received a letter informing us that a non-owner occupied short term rental (STR) has been proposed at 921 Holiday Drive. In compliance with recently adopted city STR rules, the owners applied for a special use permit that would allow them to operate the STR, and letters were sent to all property owners within 400 ft. of the proposed STR. The adjacent property owners submitted a protest petition against the issuance of this permit. The special use permit and the petition were considered at the March 5 meeting of the City Commission. owners claimed they spent over \$220,000 to purchase and completely renovate the house. They also stated they live only 40 minutes away, and could manage the STR effectively. Petitioners claimed that the large size of the house (5 bedrooms, up to 9 occupants) and the absent owner make it a bad fit for the neighborhood. The City Commission voted 4-1 to deny the application for a special use permit.

Update on Adoption of Centennial Park

After a disappointing turnout in October, the 2019 adoption of Centennial Park was shelved for lack of support. However in January, Cub Scout Pack 3055 Cubmaster Tom Hegeman, and SHNA Secretary Clint Idol contacted the Executive Committee and offered the help of Pack 3055 to periodically clean the park.

As a result, SHNA will go forward to adopt the park for this year! We will be responsible for cleaning (picking up litter) in the park once in Spring, in Summer and in the Fall. We need a crew of about 10 people to work for one hour on a Saturday. We need people in the neighborhood association to volunteer, in addition to the cub scouts. The dates and times will be:

- April 27 at 1 p.m.
- July 27 at 9 a.m.
- October 26 at 1 p.m.

If you volunteered at any of the clean-ups last year, you should hear from Phyllis around the first of April.

Ludlam Park in the News

<u>A November, 2018 Lawrence Journal World article</u> included news about Ludlam Park, a pocket park in Sunset Hill.

"Mark Hecker, assistant director of the City of Lawrence's Parks and Recreation Department, said the department conducted a citywide audit of the playgrounds and found four of 38 total playgrounds to be in poor condition and seldom used by the public.

Hecker presented the audit report to the city's Parks and Recreation Advisory Board on Monday and suggested the four playgrounds should be removed. He told the Journal-World that no official plans existed to remove the playgrounds yet but that they would likely be taken down in 2019.

The four playgrounds include a slide in Woody Park, 201 Maine St.; a swingset in Ludlam Park, 2800 W. Ninth St.; a slide and swingset in Park Hill Park No. 1, 500 Oklahoma St.; and a playground set with various features in Edgewood Park, 1245 E. 15th St."

The Executive Committee contacted Mr. Hecker, and expressed our interest in being involved in plans for changes to Ludlam. Mr. Hecker assured the Committee that we would be involved, and agreed to discuss the park with us at our Annual Meeting, April 16, 2019, 7:00 p.m., West Middle School Cafeteria. **Please join us for this important discussion!**

Major Changes at Ninth and Iowa

A mid-major redevelopment at the southeast corner of Ninth and Iowa is working its way through city planners.

"(<u>Lawrence Journal World</u>) The Tulsa-based convenience store chain has struck a deal to buy the Zarco convenience store at Ninth and Iowa streets. Plans filed at City Hall show QuikTrip would undertake a major redevelopment of the site. It would tear down the existing convenience store, plus a car wash building to the east and a vacant convenience store building just to the south of the property.



It would replace those three buildings with a new 5,000 square-foot QuikTrip convenience store that would have six double-sided pumps, meaning they could accommodate about 12 vehicles at a time. In addition, the plans call for a large parking lot of about 40 spaces. Also, the project would keep the existing Scooters drive-thru coffee shop that is on site.

The Ninth and Iowa corner is unique in that it has a small cutthrough street — West Ninth Street Terrace — that allows motorists to turn right off of Iowa Street and get onto Ninth Street without going through the signal at the intersection. Plans call for the fuel pumps to be on the north side of Ninth Street Terrace, while the QuikTrip building would be on the south side of the street. A note in the application says the project would seek to acquire the right-ofway of Ninth Street Terrace, meaning it no longer would be a city street."

The developer is asking the city to replat the two lots as one lot and to vacate West Ninth Street Terrace. This would effectively remove it as a route to Ninth.

Hillcrest Neighborhood Association has contacted city planners to express their concern that closing the street may increase the number of motorists heading north on Iowa cutting through their neighborhood. City planners have asked the developers to add a right-turn lane on Iowa south of Ninth to speed traffic through this intersection. Once the planners and the developers have agreed to a site plan, both the replat and the site plan will go before the City Commission. SHNA Executive Committee will continue to follow the process of this redevelopment.

SHNA Executive Committee Seeks Volunteers

Businesses in Sunset Hill Neighborhood

As you have noticed, the last two issues have included a list of all businesses in Sunset Hill in the left sidebar. Are you surprised at how many there are? I was! Our neighborhood has a vibrant commercial perimeter!

Former President Jeanne Pees suggested that the newsletter could benefit from some information about SH businesses, so she gathered information about two of our neighbors, The Merc Co+op and Orchards Drug. Here is what she discovered about these two businesses at opposite ends of the neighborhood.

The Merc Co+op

The Merc Co+op, a full service grocery store originally known as The Community Mercantile, started as a small group of Lawrencians with a shared passion for access to whole foods. Together they formed a volunteer-run, organized buying club distributing bulk foods out of a

member's basement. In January of 1975 the co-op moved to 730 Massachusetts St. and moved several more times on Massachusetts before moving to 7th and Maine in 1977. After many years at that location, the Merc moved to what is now Cork and Barrel Downtown at Ninth and Mississippi. Finally in 2001 with 1500



members-owners, The Community Mercantile, fondly known as "The Merc", moved to its current location at 901 Iowa Street expanding operations to include a full service meat and seafood counter, deli, cafe and community classroom. Today, the co-op is owned by nearly 8,000 members-owners and serves as a livable wage employer for over 100 Kansas residents.

Tax Fraud - How to Keep Your Information Safe

The holidays are long over, cabin fever has hit, and nearly everyone is ready for spring, but that also means the April 15th Tax Day is looming in our near future. Many of us will be busy compiling our financials, sending it off to our tax professional, and waiting (hopefully) for the refund. But how can we be sure all of this information goes to the right place?

Tax season is the perfect time for scammers to gather information: after all, so much of it is being transferred in between companies, employees, tax professionals, and the IRS. Scammers see this as the perfect window to steal someone's information and even file fraudulent tax returns to steal your refunds. Here are some tips and tricks to make sure that scammers have less of a chance to steal your information:

First, it is important to remember if there is ever actually a problem with your taxes there are certain things the IRS will NEVER do. They will never ask for personal information via social media, email, or via text. If there is a problem, the IRS will notify you by mail first. They also will not threaten you with arrest or to suspend your driver's license, and they will not ask you to wire money, use a prepaid money card, or ask for credit card information over the phone. If you receive a call with any of these characteristics try and write down the alleged name of the person calling, phone number, and any other information from the call. Report the call as soon as possible to the FTC at FTC Complaint Form or 877-FTC-HELP. Also, report it to the Treasury Inspector General for Tax Administration (TIGTA) at TIGTA Complaint Form or call 800-366-4484.

Another important tip is to evaluate your tax professional if you choose to use one. Tax professionals are, for the most part, credible, but you want to be certain. Be especially wary of those promising an abnormally large tax return, and always ask for a Preparer Tax Identification Number. You can also checkout your tax professional's history with the Better Business Bureau. In order to keep your information safe it is best not to give it out until you have confirmed your tax professional's credibility.

Sunset Hill Elementary School Convinced that the church is people and not a building, we are a congregation always in-process. This process is pointed to in our mission statement- "Christ Community Church desires to become a community of people madly in love with Jesus." A model for our church community is Belong-Believe-Become. We purposely placed "Belong" before "Believe" because we want to be a welcoming place for those that may not yet believe, but are interested in exploring Christian beliefs.

We have a well-staffed Sunday morning nursery, but infants are welcome to stay with parents too. Our Sunday morning worship time begins with a few moments of meet and greet. This is followed by multi-generational worship teams leading young and old singing a mixture of hymns, sometimes with updated styles, and current songs that might be heard on Christian radio or at a concert. After praise and worship our children are dismissed to Destination Kids for age-appropriate games, singing, and discipleship activities. A unique aspect of our Sunday mornings is that before the sermon we invite those in attendance to share a brief prayer and each week time is made for a community representative, visiting missionary, or someone from our congregation to share a personal story about their life and/or work.

On Wednesdays age-specific student groups 4th-12th grades and several adult Bible studies also meet. Free childcare is provided for 3rd grade and younger. We celebrate our house groups too!

We seek the welfare of our city. We hope that we are known as an involved, yet unassuming group. For example, we volunteer on the KU and Haskell Indian Nations University campuses, work with LATTE- Lawrence Anti-Trafficking and Education, and support the Insight Women's Center. Nearby residents might have been given bags with tomatoes, peppers, or potatoes from our community garden. With three full-time staff and a part-time children's director it is our desire to be better serve the Sunset Hill neighborhood. Our ears are open to your suggestions!"
