# **Notes from the EC**

SHNA Executive Committee Meeting Monday, August 16, 2021, 6:30 pm Fellowship Hall, Christ Covenant Church, 2312 Harvard Rd

In Attendance: Bill Arick, Dillon Heter, Mariana Nieto, Matthew Paul, Gary Webber

- I. Approve May 24, 2021, minutes: Heter moved to accept, Nieto seconded, passed by acclamation.
- II. Treasurer's Report: Arick reported starting balance of \$1297.77, \$222 mailing expenses, no new members. \$1075.77 ending balance.
- III. Old Business
  - Lawrence Association of Neighborhoods (LAN) update: In May, Lawrence Front and CENTER presented a collection of design ideas for downtown pedestrian and bicycle facilities. Heatherwood Heights NA announced they are opposing the installation of an Evergy substation adjacent to their neighborhood. In June, LAN received a presentation by City Transit Staff regarding proposals that will be submitted for KDOT's 2021 Access, Innovation, and Collaboration Grant (AIC). In July Webber reported to LAN regarding the Climate Controlled Mini Warehouse proposal for Centennial and Yale.
  - 2. Plan for Annual Meeting and Picnic, Saturday, Sept. 18
    - i. Stuff and stamp member invitation letters
    - ii. Volunteer(s) to take apps and \$ for Bill Arick: Nieto volunteered to collect apps and \$
    - iii. Plan for Potluck entrée order and pickup: Paul will order and bring pulled pork for 35. Webber will bring place settings and beverages.
  - Recruiting new EC members (2) for 2021-2022: No candidates have been willing to serve on the EC. If we are unable to find replacements, we will conduct EC business while continuing to recruit.
  - 4. Business Membership Drive update: The subcommittee has 20 applications and 5 traffic safety posters each. They will be visiting businesses this fall.

- 5. Spring new neighbor packets update: John and Kristy White delivered 17 new neighbor packets and visited with 4 new property owners.
- IV. New Business (Webber)
  - 1. Webber proposed purchasing 4 trash grabbers for \$120 and 4 buckets for \$10 for Centennial cleanup crew. Webber moved to purchase, Paul second, passed unanimously.
  - 2. Neighborhood Traffic Management Program update
    - i. SHNA Member Survey: 39 responses; Webber will send data from survey to members after closure on Aug. 20.
    - ii. Crash data: Webber will make this available with survey data.
  - 3. Bus route redesign and Transfer Hub design update: both are ongoing, City Commission decides whether to proceed with suggested design on Aug 17. (Note: The commission voted to proceed with the Bob Billings facility as designed but deferred the Downtown facility design decision pending further study and input by downtown businesses.)
  - 4. Hillcrest Storage Proposal update: City Commission did not initiate a text amendment.
- V. New agenda items from participants
  - Unity Church storm shelter: Paul reported that he has contacted Unity Church and they have provided access to the church during tornado warnings. Paul is finalizing a method to send out emails and text messages to the 10 member households nearest the church.
  - 2. Set date and time for fall meeting in early December: Monday, Dec. 6, 2021.
  - 3. Adjourn meeting: Merrill moved to adjourn, Paul seconded, motion passed by acclamation at 8:25 PM.

# **Results of the SHNA Traffic Safety Survey**

The Lawrence <u>Neighborhood Traffic Safety Program</u> has been soliciting applicants from among the organized neighborhood associations for the first round of the Traffic Management Pilot Program. SHNA decided not to participate in the pilot program last fall, not because we have no traffic safety issues, but because we have no data on which of several problem areas to address first. Old West Lawrence was selected for the initial pilot study.

To remedy this, the EC asked members to nominate traffic safety problem areas, and then surveyed members to rank the 9 nominated locations. You may view the data from the survey here, along with information from the 2011-2021 KDOT crash data for our neighborhood. You should have received this link in an earlier e-mail.

The three locations that were voted most important to address are:

- Crestline Drive and Harvard Road at school drop-off and pick-up times where illegally parked cars and backed up traffic make the intersection dangerous,
- 2. Crestline Dr. from Harvard Rd. to Stratford Rd. where a hill and curve obstruct the vision of motorists from both directions, and
- 3. Jana Dr. from Holiday Dr. to Harvard Rd. where cars parked on both sides of the street and the absence of sidewalks creates hazards for motorists, pedestrians, and bikers.

This fall, the traffic safety subcommittee will meet to discuss the survey results and prepare to apply for the next round of city funds. If our application is

# **City Commission Votes Against Code Amendment**

You may remember that The Raney Group tried unsuccessfully to rezone the parcel of land at Yale Rd. and Centennial Dr. (currently a parking lot) to build a 54,000 square foot, 3-story climate controlled mini-warehouse.

On July 6, 2021 they returned to the City Commission with a request to initiate a text amendment to the City of Lawrence Code adding mini-warehouse as a permitted use in a CN2 (neighborhood commercial) and RMO (multi-family residential/office) districts. In other words, if they were not permitted to change the zoning of the parcel to Commercial Strip, they proposed to change the Code to allow their project in all CN2 and RMO districts. Mini-warehouse is currently not a permitted use in these two districts.

The SHNA Executive Committee opposes this amendment to the City Code and sent a letter to the commission asking them to deny the request. In part, our letter stated:

"The owners of Hillcrest Shopping Center are now proposing to amend the Lawrence Land Development Code to allow this project to continue. The SHNA Executive Committee opposes this text amendment. We support an appropriate mixture of commercial and residential uses within and around residential neighborhoods. This amendment would expand the permitted uses of a neighborhood commercial district and a single family residential/office district to include a higher intensity, inappropriate commercial use."

The City Commission was clear in their opinion of this type of tactic. Commissioner Shipley pulled the request to initiate from the consent agenda, and the commission voted to deny the request to initiate the amendment. The developers could bring the amendment initiation request back at a future meeting. The EC encourages the Raney Group and Paul Werner Architects to find an appropriate parcel in a properly zoned district to build their miniwarehouse.

# **Business Membership Drive Underway**

For the first time in its 30-year history, SHNA is reaching out to the approximately 109 businesses in our neighborhood. EC members Dillon Heter, Matthew Paul, and Gary Webber are currently visiting each business in person and inviting them to become members of SHNA. We currently have two business members, Buckingham Palace on 6<sup>th</sup> St. and Sew Forth Alterations in Hillcrest Shopping Center. Business members pay \$10 annual dues, receive the quarterly newsletter, may bring issues to the Executive Committee, and may vote at the Annual Meeting.


