 - 14. The EC nominated Jon Dunham to serve a 2-year term to replace outgoing member Marlene Merrill

Webber asked for nominations from the participants for the remaining 3-year term. There were no nominations from the participants. The nominated slate was voted in unanimously. There is one position open on the Executive Committee.

- V. Questions from members
 - 1. Noisy cars and motorcycles are a problem. In France they have a system of sound meters and automatic cameras that efficiently ticket offenders. Couldn't we have such a system here? Webber encouraged the member to speak before the Multi Modal Transportation Commission and the City Commission and suggest this solution. Noise concerns should be reported to the non-emergency police dispatch. Webber stated that he and the EC agree with him that noise is a problem.  - 2. Speeding and cut-through on Holiday is habitual. Increased Police presence and enforcement are required. Webber stated that part of the funding for the Neighborhood Traffic Management program was for enforcement, in addition to mitigation efforts. He described the recent survey of the membership and stated that the results indicate our collector streets are of greatest concern to those completing the survey. KDOT crash data shows That the highest number of crashes during the last decade occurred on Ninth and Crestline. He encouraged the meeting participants to get involved with the neighborhood's application for funding in early 2022. Contact president@sunsethillna.org.

Living in the City

Solicitors, Peddlers, and Transient Merchants

Here is a reminder that solicitors, peddlers, and transient merchants need to have a license in Lawrence for door-to-door sales, according to city regulations. For details regulations, refer to page 42, Chapter 6 Article 8 of the City Code of Lawrence.

Also, be alert of the perennial door-to-door scams, including "I've got a freezer full of steaks", magazine sales, and "white van" speaker sales, among others. If someone isn't displaying their solicitor's license or doesn't have one, you can call into non-emergency dispatch at 785-832-7509 to have an officer come out to investigate.

Exterior Lighting and Light Trespass

The Lawrence Land Development Code (LDC) contains ordinances which regulate exterior lighting, both residential and commercial. These codes address issues related to light trespass and ensure that exterior lighting in Lawrence is sized and positioned to maximize safety while minimizing glare.

Light trespass occurs when spill light is cast where it is not wanted. An example of light trespass is when spill light from a streetlight or floodlight enters a window and illuminates an indoor area.

This can be especially troublesome for homeowners when bright light from an adjacent property illuminates their bedroom windows and disturbs their sleep. Light trespass is regulated by city code, and if it is determined to be occurring, the city can require the owner of the offending fixture to modify it to eliminate trespass.



Glare is a visual sensation caused by excessive and uncontrolled brightness. It can be disabling or simply uncomfortable. It is subjective, and sensitivity to glare can vary widely. Older people are usually more sensitive to glare due to the aging characteristics of the eye. The most common source of glare is looking directly at a bright source of light, like an oncoming headlight or a bright wall-mounted fixture. In an urban environment, glare can be reduced by requiring that fixtures be shielded to reduce glare.

When you are selecting exterior light fixtures for your home, be aware of trespass and glare. Use bulbs on front porch lights that are equivalent to 60W incandescent bulbs or smaller, no more than about 800 lumens. Use fixtures



that shield the bulb and point light downward. If you install a "security" light, make sure to point the fixture downward to illuminate only your property. The LDC states "spot lights or flood lights that create a glare on neighboring property are prohibited." If you add lighting for security, use a motion detector, and make certain the fixture

head is angled to keep the light on your property. This is especially important on lights that are close to the property line and neighboring structures.

Homeowners may want to justify glare and trespass by claiming they need the light for security. Lighting the area immediately around the structure does allow tresspassers to be more readily seen, but floodlights that are pointed out to the side and illuminate the street or adjacent properties create glare and shadows that makes it more difficult for your neighbors or a police officer to see intruders around your home.

Use exterior lighting carefully, and make sure that the light from your property stays on your property. To learn more about the city outdoor lighting ordinances, <u>follow this link to the Land Development Code</u>. You will find the outdoor lighting ordinances on page 348 (11-10), Chapter 20, Article 1103, "General Development Standards".
